Subject: - **FINANCIAL ASSISTANCE TO THE FAMILY OF A CIVIL SERVANT WHO DIES WHILE IN SERVICE**

Sir

I am directed to refer to the subject noted above and to say that in order to provide financial relief to the families of civil servants who expire during service Administrative Departments in absence of any criteria, recommend ex-gratia grants in certain cases, leaving an impression of disparity. Moreover only a few families have been allowed financial assistance. Need has therefore been felt to provide an umbrella cover to all bereaved families to meet their financial problems that crop up after the demise of the only earning member. Accordingly, to bring adhoc dispensation within the frame work of

a prescribed policy, the competent authority has been pleased to approve with immediate effect a criteria servants who expire during service as under:-

<u>BASIC SCALE</u>			<u>AMOUNT</u>
01	to	04	Rs. 200,000/-
05	to	10	Rs. 300,000/-
11	to	15	Rs. 400,000/-
16	to	17	Rs. 500,000/-
18	to	19	Rs. 800,000/-
20	&	above	Rs. 1,000,000/-

2. This will be in addition to other benefits admissible to the family of deceased civil servants under rules.

3. Administrative Department / Appointing Authorities will issue sanction in individual cases. All the cases initiated by or under process in the administrative Departments are to be disposed accordingly.

4. Expenditures involved will be met out of the existing budget grants of the Administrative Department / Districts Governments however; in case additional funds are required the case will be referred to Finance Department for provision of funds with justifications.




