The Judges of the High Court will observe winter holidays from 26-12-2020 to 09-01-2021 and all Civil & Sessions Courts as well as Federal and Provincial Tribunals/Special Courts in Sindh working under the Administrative Control of High Court of Sindh will observe winter holidays from 26-12-2020 to 03-01-2021.

3) The District and Civil Courts will observe two (2) local holidays within their District during the year 2020 to be declared as Local holidays by the

concerned Deputy Commissioners/Administrators.

4) The Officers/Officials desiring to avail of optional holiday shall take prior permission of the Head of the Department concerned and no one shall be granted more than one optional holiday in the case of Muslims and three optional holidays in case of non-Muslim in a calendar year.

The grant of this concession should not result in any dislocation of work and even in case of Muslim optional holidays the number of persons permitted to avail these holidays should be regulated in a manner so as to

leave adequate staff for proper continuance of work

6) The optional holidays are denominational and may be allowed at the discretion of the Head of the Office provided the state of work permits.

7) A Government servant would not ordinarily be refused an optional holiday which is of religious significance to him, if the refusal is likely to decrease the maximum number of such holidays to which he is entitled,
