Subject: ILLUCIDATION OF EXSISTING UNIT STATEMENT FORMULA.

With reference to the cited subject and referring to existing unit statement formula already circulated and to further elaborate it, in the following category of cases, units shall be reckoned as follows;

Sr. No	Category of Cases.	Unit Entitlement as per Unit Statement Formula
1.	Criminal Cases: Before Court of Magistrates Where accused pleads guilty.	02 Units.
2.	Criminal Cases: Before Court of Sessions. Where accused pleads guilty.	02 Units
3.	Criminal Cases: Summary Cases (A Class, B- Class, C-Class)	No Units as per unit Statement Formula.
4.	Criminal Cases: Special Laws which provides Summary Trial.	03 Units.
5.	Family Cases: Ex-Parte matters.	02 Units

Application u/s 07 read with sec 10 of Guardian and Wards act, 1890.	1-Cases where no respondent/opponent is impleaded party other than Public at large. 02 Units as Unit statement formula. 2-Cases where opponent (i-e Father, Mother, Brother, Sister, Father-in-law, etc) is impleaded party who extends no objection for grant of issuance guardianship certificate. 02 Units as Unit statement formula.
9.	Guardian and Wards cases. Ex-parte. Application u/s 25 of Guardian and Wards act, 1890	02 Units.
10.	Civil Cases. Disposal of cases u/o 15 rule 1 CPC, 1908.	02 Units.
11	Civil Cases. Disposal of case u/o 12 rule 06 of CPC, 1908.	02 Units
12.	Family, Civil and Guardian cases: Compromise matters.	02 Units.
13.	Family, Civil and Guardian cases: Withdrawn matters.	02 Units.
