OFFICE MEMORANDUM

No.FD(SR-III)3-1074/2021:-In supersession of this Department's letter No.FD(SR-III)3-629/2020, dated 24th November, 2020 and in light of opinion of Advocate General, Sindh received through Regulation Wing, Services General Administration & Coordination Department vide U.O Nos. SOR-III(SGA&CD)9-25/2019, dated 9th August, 2021 and SOR-II(SGA&CD)5-13/2022 dated 7th November, 2022, regarding interpretation of Rule-41 & 42 of Sindh Civil Services Rules, Manual Volume-I, it is clarified that the Basic Pay of the incumbent will be protected from higher to lower grade subject to the condition that his/her lien is kept in the previous service and subject to other provisions as specified vide this department's Circular No.FD(SR-I)1(30)/83, dated 3rd June, 2016.

2/- It is further clarified that the Basic Pay of the incumbent of lower grade and drawing salary in higher grade on the basis of time scale will be protected upon his/her promotion. However, other allowances such as house rent allowance, conveyance allowance, etc., shall be admissible as per the scale of post on promotion.






