Salahuddin Panhwar, J.- Partly heard learned counsel for applicant as well as learned *amicus curie*. Pursuant to order dated 24.01.2019, AIGP, Legal-II is present and submits report. At the outset, it would be conducive to refer paragraph No.8 of order dated 24.01.2019 which is that:-

Since, in the case of Nasrullah, a good coordination of all concerned, including Court (s) was insisted and each institution was asked to perform its role, therefore, IGP Sindh shall ensure complete breakup of remaining pending cases including Districts of Karachi as well initiatives, if so far taken after circulation of judgment of Nasrullah. Needless to mention that Prosecutor General Sindh's office is, otherwise, directly concerned to supervise investigation hence PGV Sindh office shall submit details of A-class cases (under investigation) as per directives, given in case of Nasrullah supra. IGP Sindh depute any responsible person to assist P.G. Sindh's office and bifurcate the cases and submit details of cases of heinous crimes separately in whole Sindh particularly Karachi; which are yet pending for arrest/ names of culprits (A-class). Moreover, CTD, SIU, AVCC, Special Branch and Crime Branch, Shall also submit details with regard to cases Which are yet pending under A-class.

president to above order, AIGP submitted report which shows

*He also submitted report of A-class cases. According to report, 75267 cases are pending for investigation wherein culprits are yet to be arrested. It is very strange that in this metropolitan city where sufficient number of police force and Rangers personals are operating but number of cases with regard to murders during dacoity, dacoity, robbery, kidnaping for ransom is not only very high but culprits thereof normally remain unknown whereby their courage to act criminally stands double. The FIR (s) against culprits, thus, never serve purpose thereof (moving of wheels of law) except increasing theap and putting feared masses into further fear which, even, is resulting into taking away their courage to report crime (s) rather

making them to prefer to surrender before criminals during crimes as well post process thereof (crimes). Such like scenario, I shall have to insist, if continues rooting tight, shall turn a metropolitan city into a *jungle*. In the report, cases of kidnaping for ransom are 4822. The total figure of all cases is around 25205 which is shocking and needs work of force on war basis.

2. At this juncture, Mr. Abad-ul-Hasnain, advocate (amicus curie) contends that since Rangers is working in Karachi and they are also in joint work with police force, therefore, notice to D.G Rangers, Sindh may be issued with further direction to assist the police officials and ensure that all cases are investigated properly and accused are arrested and sent up to the trial. There can hardly be any denial to the fact that root purpose of Pak-Rangers in cities is nothing but to ensure restoration of peace thereof. The peace can't be expected unless the every criminal receives his due which, first, requires identification of criminal and then sending him up to face the trial. It is the time to take Pak-Rangers into confidence in the issue, involved. Let the notice be issued to D.G. Rangers who, hopefully, shall come forward with some mechanism of Pak-Rangers role in identification least arrest of criminals of heinous crimes. All the earlier orders, so far passed in matter, be also communicated so as to make him aware of gravity of issue. Besides, this report shall be submitted to District and Sessions Judges, through MIT with further directions that all Judicial Magistrates shall call reports of FIRs from their respective areas and ensure that investigation is supervised and concrete steps are taken without burdening the private complainants by compelling their appearance unless, otherwise, justified. With regard to investigation and arrest of accused, Judicial Magistrates shall maintain the record of A-Class cases separately and that shall

be the part of pending cases and Case Flow Management System (CFMS) and shall flash the number of cases on website. The Judicial Magistrates would be competent to call Investigation Officers or would direct SSPs to supervise the Investigation, in case any officer is transferred or not available due to any reason till proper handing over of investigation.

- 3. At this juncture, Mr. Muhammad Daud Narejo, advocate for the petitioner in connected petition No.S-1219/2018 contends that CRO maintained by the DIG, CIA is not in accordance with law. It has further come on record that the same is not having any nexus with the record maintained by the Jail Authorities. The CRO must be proved to have been properly maintained. If maintained properly, there shall always be nexus and matching. Accordingly IGP, Sindh and IGP, Prisons, Sindh shall ensure that CRO pertaining to whole Sindh Province is categorized with separate Divisions and shall be maintained by their joint venture and every Investigation Officer or police officer shall be provided access to other CROs and it shall be maintained and linked with other Districts. Needless to mention that such CRO shall be separated with regard to convicted and acquitted accused persons. The Chairman NADRA shall also provide necessary access and facilities to IGP, Sindh to maintain the CRO with verification.
- 4. It has come on record that every FIR is being maintained on computer and is linked with CRO office, therefore, there should be nexus of CRO office with CRO record maintained by concerned office, who is maintaining record of CRO and in case any accused is hardened criminal and having other cases, immediately that report

shall be sent/conveyed to the concerned I.O. In cases against society

like murder, decoity, robbery, kidnaping for ransom, theft or rape, the I.Os shall ensure, if name of accused is surfacing in FIR or surfacing for investigation, I.O shall verify it from CRO office whether any other case is pending against that accused? If the answer is positive then same shall be the part of his report and legal course shall be followed in investigating that accused.

- .5. At this juncture, Mr. Muhammad Hanif Samma, advocate (Amicus Curie) emphasis on paragraph No.5 of order dated 26.2.2019 and further he has emphasised on order dated 12.3.2019 which reflects that representative of Law Department was present and sought time to examine the Sindh Criminal Courts Rules 2012 and proceed further for legislation in accordance with law. However, no positive response is there except such a commitment which (commitment in court proceedings) has legal weightage as well consequences in case of failure. Ignoring it for time being, I find it appropriate to call the Secretary, Government of Sindh, Law Department, who shall be in attendance on the next date and shall submit report as well as learned MIT shall ensure that Rules are provided to all Judicial Magistrates and the same shall be complied with.
- 6. At this juncture, Mr. Abad-ul-Hasnain, advocate (Amicus Curie) contends that though CCTV Cameras are available on almost every road and every public place in Karachi or in other Districts of Sindh, but it is not observed in any case that any Investigation Officer has taken pain and submitted any captured CCTV footages. It is admitted by the police officers present in Court that CCTV directorate is established in Civic Centre. The purpose of CCTV cameras in city as well establishing of a Civic Centre, prima facie, is meant to ensure

immediate identification of culprits and then arrest. Needless to mention that in this modern era, CCTV is the best source to arrest the accused as well the best source of evidence but police officials/investigation officers are not taking any interest thereby making the very objectives of such huge investment a failure which, too, at the cost of peace of the Cities rather they look for the expertise to investigate the cases through CCTV and DNA. Therefore, IGP, Sindh shall ensure that training programs shall be launched whereby at least 50 officials in Karachi and 20 officials in each Region/ Division of Sindh shall be trained, particularly with regard to DNA and collecting evidence through CCTV Cameras and lock tracking. Such report shall be submitted on next date. The said training shall be initiated under the provision or with the help of any qualified agency, private or public. It is time to remind that a clear footage must be shown to have been used to get identification known with help of NADRA which (NADRA) was / is also aimed to ensure such facility on a single click. Accordingly, the report should also be submitted as to whether any measures were taken in cases of clear footages of criminals which cases, otherwise, sent up with A-Class * report.

7. At this juncture, Mr. Muhammad Hanif Samma, advocate (amicus curie) contents that funds are not properly provided by the Government of Sindh to the Police Department. Accordingly, the Home Secretary and the Finance Secretary, Government of Sindh shall submit detailed report with regard to allocation and release of funds of last three years to the Sindh Police on the next date so that report be called from concerned quarter as to whether the objective of

a Rocation of fund was ever achieved or otherwise?.

- Counsel for the applicant contends that though report was 8. submitted, but that was not considered though sufficient evidence was available with the I.O but he failed to file report for submission of challan. Further, he contends that learned XIV-Judicial Magistrate, Karachi East has relied upon report of earlier I.O. I am surprised that how any report in matter of 'A classes' can result into disposal of such FIR without first disclosure of accused and then trial thereof?. The report (s) of investigating officer (s) have never been given the binding status because it is absolute domain of Courts. Accordingly, learned District and Sessions Judge, East Karachi shall refer the report in FIR No.264/2018, P.S Ferozabad, Karachi, who shall transfer it to another Judicial Magistrate, who shall pass fresh order on "A" class report submitted by police as well learned Judicial Magistrate shall ensure compliance of further proceedings within spirit of Nasrullah case reported in PLD 2015 Sindh 238.
- 9. At this juncture, counsel for the applicant contents that there are serious threats to the father of the applicant who is residing in Khairpur District. Accordingly, SSP, District Khairpur shall ensure that complete protection is provided to the applicant, his father and his other family members in accordance with law. Such report shall be submitted before this Court.

In this connection, reference is respectfully made to this office earlier letter No. 915 dated 04-03-2019 whereby copy of order dated 26-02-2019 passed in subject case, along with copy of Sindh Criminal Courts Rule, 2012, were sent to your good office through email for forwarding to all the Magistrates in your respective districts, for necessary action and compliance.

It may be recapitulated that vide above order dated 26-02-2019, the undersigned was directed to ensure that all Magistrates of the districts shall examine these Rules.

It is, therefore, again requested to repeat such directions to the Magistrates with regards to order dated 26-02-2019, in your respective districts for necessary action and compliance.
