


CIRCULAR

In suppression of all previous notifications regarding statement under Section 164 Cr.P.C all the concerned Judicial Magistrates are directed to record statements under Section 164 Cr.P.C of their respective jurisdiction except in case which is triable by such Judicial Magistrate, the Incharge Judicial Magistrate Judge shall record such statement. In case of rape victim following Female Judicial Magistrates are nominated to record statements under Section 164 Cr.P.C in the order as mentioned hereinabove: -

It is clarified that all the applications under Section 164 Cr.P.C. shall be received and entertained by the Judicial Magistrate having jurisdiction or in case of trial by said Judicial Magistrate by his Incharge Magistrate and in case of rape victim by the concerned lady Judicial Magistrate. No Judicial Magistrate shall receive application and pass order on their own and then refer the same to concerned Judicial Magistrate for recording such statement, as the same would amount distribution of business which is the sole domain of District & Sessions Judge. All the Judicial Magistrates are directed to ensure strict compliance of the order made hereinabove and in case of any violation stern action shall be taken. Let this circular be sent to concerned SSPs who shall circulate to all SHOs of their respective jurisdiction for strict compliance information with direction that any application under Section 164 Cr.P.C shall be made directly to concerned Judicial Magistrate in the order as mentioned hereinabove.
